

**ELIGIBILITY:** NO PURCHASE NECESSARY TO ENTER OR WIN. The Texans Credit Union “Youth Month Contest” program (“Program”) is open to children ages 0-17. Entries must be submitted by a family member who is a legal U.S. resident and is 18 years or older at the time of entry. The Program is void where prohibited by law. Participation constitutes entrant’s full and unconditional agreement to these Official Rules and Sponsor’s decisions, which are final and binding in all matters related to the Program. Winning a prize is contingent upon fulfilling all requirements set forth herein. An eligible “Member” for the purposes of the Program means the primary accountholder of a Texans Credit Union Savings Account is in good standing (as determined by Sponsor in its sole discretion) at the time of entry and at the time of drawing. In the event of a dispute as to the identity of a winner, such entry will be deemed to be submitted by the primary accountholder of the Eligible Texans Credit Union Account in question. Employees of Texans Credit Union, members of the Board of Directors, its affiliates and their families residing in a single household are not eligible. Some restrictions may apply.

**TIMING:** The Program begins at 12:00am CT on April 1, 2024, and ends at midnight CT on April 30, 2024 (“Promotion Period”). There will be two (2) random drawings at the end of each of the five (5) Weekly Drawing Periods during the Promotional Period (drawing period detailed below), from among eligible entries received.

**HOW TO ENTER:** Between April 1, 2024, and April 30, 2024, obtain a copy of the coloring sheet and/or activity sheet (“Project”) from a Texans Credit Union branch or download from our website. Submit the completed Project, including the youth’s name and age, adult’s name, phone number, and email address, using one of the following methods: drop off at any Texans Credit Union branch; electronic submission to [MemberService@TexansCU.org](mailto:MemberService@TexansCU.org) with the subject line “CU Youth Month 2024”; or mail to Texans Credit Union – Youth Month Contest, 777 E. Campbell Road, Richardson, TX 75081. Limit one (1) entry per participant. Entry forms cannot be mechanically reproduced. All entries must be received prior to the end of the promotion period. Incomplete entries, late entries, or entries not complying with the Rules are subject to disqualification at the Sponsor’s sole discretion. Texans Credit Union is not responsible for lost or otherwise compromised entries.

**ODDS:** Estimated odds of winning a prize depend on the number of eligible Entries received by the end of each applicable Weekly Drawing Period and in compliance with the exact requirements of these Official Rules.

**PRIZES:** Two (2) prizes will be awarded at the conclusion of each Weekly Drawing Period, as chosen by random selection in a drawing from all eligible Entries. Each winner (accountholder on the membership) will receive \$100.00, to be deposited into their Texans Credit Union Savings Account. If the winner selected does not have an account with Texans Credit Union, the winner (adult name listed on the entry) will receive a \$100.00 check. (Maximum value of all prizes: \$1,000.00 USD). Limit one prize per account or entrant. The decisions of Texans Credit Union, including the selection of the winners, are final and binding on all matters related to the Program.

**PRIZE DRAWINGS:** Two Prize Winners (subject to verification) will be selected each week, on the dates listed for the Weekly Drawing specified below. The Drawings will be conducted from among all eligible entries received by the day prior to the Drawing Period. The Weekly Drawing Periods are as follows:

**NOTIFICATION:** Winners will be notified via phone or email. Texans Credit Union will deposit \$100.00 into the accountholder’s Texans Credit Union Saving Account within 30 days of the Promotion Period end date. Winners who do not have an account with Texans Credit Union, will be notified by phone or email on the Entry submission. Winners may be required to complete an address confirmation letter. Please allow 6-8 weeks from the end of the Promotion Period for winner validation and delivery of prizes.

**PRIZE CONDITIONS:** Texans Credit Union is not responsible for any notification, documentation or prize that is returned as undeliverable. In the event any documentation or prize is returned as undeliverable, that prize will be forfeited and will not be awarded. Prize must be claimed within 30 days of notification, or an alternate winner will be chosen. Required

documents must be returned within the time specified or the potential prizewinner will be disqualified. Taxes, if any, are the responsibility of the individual winner; a Miscellaneous Form 1099 may be issued as required by law. No transfer or assignment of any prize is permitted, except at the sole discretion of Texans Credit Union. By entering this promotion and accepting a prize, each winner consents to the use of his/her name, photographs, voice recordings and likenesses for publicity purposes without additional compensation or permission (except where prohibited by law). Texans Credit Union will not be responsible for any act of God, acts of terrorism, civil disturbances, work stoppage, force majeure, or other event, condition, or occurrence outside the control of Texans Credit Union that may cause the failure to deliver any part of the prize or the entire prize.

**PROGRAM LIMITATIONS:** This Contest is subject to suspension, cancellation, or modification at any time without prior notice or liability if the integrity of the program is compromised in any manner as determined by Texans Credit Union. Texans Credit Union reserves the right at its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Program, or to be acting in violation of these Official Rules. Texans Credit Union's failure to enforce any term of these Official Rules will not constitute a waiver of that provision. Under no circumstance will more prizes than those set forth in these Full Official Rules be awarded. All winners and entries are subject to verification and compliance with these Full Official Rules. All entries become the exclusive property of Texans Credit Union and will not be acknowledged or returned. By participating in this program, entrants accept and agree to be bound by these Official Rules and the decisions of Texans Credit Union.

**WAIVER OF LIABILITY:** Except where prohibited, all entrants agree to release and hold harmless Texans Credit Union and its subsidiaries, affiliates, officers, directors, employees, agents, independent contractors and all others associated with the development and execution of this program from any and all liability with respect to, or in any way arising from, or in connection with: a) his/her participation in this program and/or the acceptance, possession or use of any prize that may be awarded to him/her, including, but not limited to, liability for personal, bodily injury, death, damages or loss of any kind; b) unauthorized human intervention in the program; c) technical errors, programming errors, transmission defaults or interruptions related to computers, mobile phones, software, servers, or telephone or network lines; d) computer server or telephone service failure and/or delayed, garbled or corrupted data transmitted by entrants; e) sending, printing or typographical errors; f) errors in the administration of the program or the procession of Entries; g) late, lost or undeliverable mail, prize awards, email or shipments; or h) any loss or damage to any participant's or to any other person's computer or electronic device relating to, or resulting from, playing or downloading any information or software in connection with the program. Each entrant hereby waives all rights to claim punitive, incidental, or consequential damages, or any other damages, including attorneys' fees, other than entrant's actual out-of-pocket expenses.

**PUBLICITY RELEASE:** Each entrant and winner grants to Texans Credit Union and each of its affiliates, agents, and representatives the right to depict, publish, publicize, license, and/or exploit all or part of their name and likeness, for advertising, promotional, and trade purposes in any and all media now known or hereafter developed, in perpetuity, without notice and without compensation, except where prohibited by law.

**GENERAL CONDITIONS:** Contest entries generated by a computer-generated script, macro or other mechanical or automated means (including photocopies) will be disqualified. In the event there is a discrepancy or inconsistency between the English language version and any other language version of these Full Official Rules or of any promotional materials, the English version will prevail, govern and control.
